Offer Price and Allocation of Public Offer Shares

The Offer Price is fixed at HK\$0.20. Applicants are required to pay the Offer Price of HK\$0.20 for each Public Offer Share together with 1.0% brokerage, 0.0027% SFC transaction levy and 0.005% Stock Exchange trading fee.

Applications for Public Offer Shares will not be processed and no allotment of any Public Offer Shares will be made until the application lists close.

The Company expects to announce level of indication of interest in the Placing, the level of applications of the Public Offer and the basis of allocation of the Offer Shares on Thursday, 15 August 2019 on our Company's website at www.handsform.com and the website of the Stock Exchange at www.hkexnews.hk.
